7. CHAIRMAN'S REPORT

- 7.1 Ngahiwi Tomoana provided a short video presentation summarising the Chairman's written report in the 2020-2021 Annual Report Booklet.
- 7.2 A summary of the report as follows:
 - Registered 1795 new members, now we are 36,883 strong,
 - BTM Iwi Cards were distributed to 9,941 members,
 - Provided pātaka (fish) to whānau for 97 tangihanga
 - NKII annual events, Waitangi Day 6,000 participated and over 5,000 attended the AGM
 - Whakanuia Matariki Events 20,000 attended the,
 - BTM NKII sponsorships we allocated to 73 individuals, teams, or organisations.
 - This year has been dominated again by COVID-19 and the iwi has stepped up when it counted to lead locally, regionally, and nationally. We have drawn on reserves and strategic relationships, to feed, clothe, and house our iwi. We are taking iwi to the world at Te Aratini Global Indigenous Festival, Dubai World Expo 2020 and we continue to work shoulder to shoulder with settlement entities and taiwhenua to support communities in need and continue to strive towards enhancing strong and vibrant whānau.

- 8.3 This year we were privileged to have Sir Ian Taylor on the board. Sir Ian has resigned to focus on his digital animation business. The company would like to wish him well in his animation venture and look forward to seeing his work on the world stage. The board now consists of four well-qualified individuals who bring a wealth of experience to guide the company through some challenging times.
- 8.4 The KAHC financial accounts, P&L, and Balance statements were somewhat delayed for this reporting year. The KAHC is re-forecasting. The newly created budget will rely on both year-to-date results as well as projections for the remaining year.
- 8.5 KAHC holds several portfolios of assets, our book records show \$72M worth of tangible assets, these are; Takitimu Seafoods Limited Partnership, Tautane Station, Kahutia Forestry, K3 Property Development, and Joint venture (JV) Partnerships within the fishing industry. Acknowledged the following Iwi Partnerships; Ngāti Whatua, Waikato Tainui, Ngāti Toa ki Porirua, Vella, and Sandfords, and equal partnering JV in our entities with our PSGs in particular, Ngati Hineuru and Tangoio South. JV Partnerships will continue to grow by partnering with other iwi and also within our rohe.
- The dividend payment has been received by NKII to the total amount of \$2.7M and due to the turbulence we faced last year, meant that we had to stagger the payments. The Covid has a large impact on the KAHC business at a global international scale and nationwide. The Pania Fisheries has been closed off and increasingly we are backing the Takitimu business.
- 8.7 'Motion that the Kahungunu Asset Holding Company Chairman's Annual Report for 2020-2021 be accepted' Moved by Nigel How, Seconded by Melissa Ihaka. All in favour Motion Carried.

9. FINANCIAL STATEMENT – Presented by Chrissie Hape

- 9.1 The following statement was read out by Chrissie regarding the unaudited nature of the financial statements. 'Ngāti Kahungunu group has been working alongside Crowe as the appointed auditors to finalise the consolidated financial statements. Due to timing of a material fishing transaction expected to take place in October 2021, the accounts were unduly delayed. We apologise for this and expect that these are signed off within the next two weeks. A summary is available on the Annual Report and on the iwi website.  - Friday 4th February nominations open
 - Friday 28 February nominations are closed off at 12noon.
 - Friday 28th February 11th March Public notice candidate names are announced.
 - Monday 7th March Receive Members' Data
 - Thursday 24 March delivery of voting mailers, progressive roll scrutiny, early processing, the special voting period.
 - Tuesday 19th April registrations close off at 4 pm.
 - Tuesday 26 April is election day, voting closes at 12noon and a special general meeting will be held. Tuesday 3rd May Declaration of results. The full detail of the election process is available online www.kahungunu.iwi.nz/nkiiboardelection2022





This work is not solely with regards to Oranga Tamariki but across the social sector. We have been working with our Crown partners to build and enable this approach.
