

Purpose, Vision & Mission

Ngāti Kahungunu lwi Incorporated, with the mandate to represent the people of Ngāti Kahungunu, is the governing body for all aspects of Ngāti Kahungunu lwi development.

The purpose of Ngāti Kahungunu lwi Incorporated is to:

- · Promote or assist the education of Ngāti Kahungunu lwi
- Promote the custody and preservation of the beliefs, customs and language of Ngāti Kahungunu lwi
- Promote the social and economic welfare advancement and vocational training of Ngāti Kahungunu lwi
- Promote personal, whānau and community health and wellbeing and raise the living standards of Ngāti Kahungunu lwi
- Promote high quality communications to and for the benefit of the members of Ngāti Kahungunu lwi

Strategic Objectives

In September 2001 consultation with whānau throughout the rohe of Kahungunu occurred. Whānau shared their views, aspirations and desires which helped shape the development of a vision to guide Ngāti Kahungunu into the future. The vision, known as Kahungunu 2026, outlines the vision and mission statements and seven identified strategic objectives to focus on. The Ngāti Kahungunu lwi Incorporated planning framework continues to outline priorities, activities and desired outcomes that link directly to the seven strategic objectives within the Kahungunu 2026 vision.


Ngāti Kahungunu Iwi Incorporated has a responsibility to provide its membership with an Annual Report, accounting for the activities and performance of the previous financial year, 1 July 2024 – 30 June 2025. This report outlines progress made against the objectives set in the 2024–2025 Annual Plan. It also highlights key initiatives undertaken to grow and strengthen our membership registration database, while providing a clear overview of the organisation's overall performance. The report further details changes in the value of iwi assets, the distribution of profits, and includes the summary financial statements, ensuring transparency and accountability to our iwi members.

This year marked our Triennial elections, which saw half the board renewed. We acknowledge the service of those board members who did not return for the extensive mahi they contributed whilst on the board. We acknowledge our new and returning board members and look forward to weaving in their skills and experience as we navigate the next three years together.

Last year was challenging in that there were national mobilisations against the Coalition Government (Hīkoi and Kotahitanga hui) along with submissions on the numerous pieces of legislation that seek to negate our rights as tangata whenua. Our iwi's journey over the past year has been marked by resilience, unity, and ongoing commitment to the betterment of all Kahungunu whānau, hapū, and communities. As we reflect on the challenges faced and the milestones achieved, I mihi to every one of you for your unwavering support and aroha, which have been the foundation of our collective progress.

This year, our Board is focused on strategic priorities that align with our long-term vision. We have strengthened our governance structures, reviewed key policies, and ensured enhanced accountability and transparency. I acknowledge the commitment of our past and current Board members, our kaumātua, and advisors, who have contributed their wisdom and guidance.

A major achievement was the successful completion of our strategic review for the new Kahungunu 2050 strategy, which engaged voices from across our Taiwhenua and Taurahere constituencies, kaumātua, rangatahi, and whānau. The extensive feedback received from the two-month road show has informed the recalibration of our organisational values and reaffirmed our commitment to Ngāti Kahungunu wellbeing outcomes. A presentation of the feedback will be given at the Annual General Meeting.

I would like to acknowledge our CEO, Chrissie Hape and her team for their mahi in improving the wellbeing outcomes of our people.

- Whānau Wellbeing: We have expanded our support for health, education, and housing initiatives, including partnerships with local providers and government agencies to address the pressing needs of our people. Our Te Ara Mātua and Te Ara Toiora are a testament to the iwi's focus on wellbeing, with nationally recognised kaupapa being led by our team.
- Housing: Our housing team in particular deserves recognition for responding swiftly to the increased demand for safe, affordable

homes. Collaborative efforts with government agencies, Councils and commercial developers have seen the completion of a number of key housing projects. This is a hugely exciting time for our housing aspirations.

- Education and Rangatahi: Our rangatahi are the heart of our future.
 This year, we increased scholarships and initiated the inaugural Kahungunu Education Symposium. We have formalised relationships with tertiary providers to ensure our youth have pathways to success grounded in mātauranga Māori.
- Economic Development: The iwi's economic arm has continued to deliver strong results. We navigated a challenging economic climate with prudent investment decisions, consolidation of our fisheries and whenua (Tautāne Station), and the growth of our commercial portfolio. Profits have been reinvested into social and cultural initiatives, ensuring intergenerational benefits.
- Environmental Kaitiakitanga: Our deep connection to te taiao has inspired projects in restoration, sustainable land use, and waterway protection. Our Taiao team continue to collaborate with local marae taiao champions, councils and Taiwhenua to ensure the revitalisation of awa and enhanced guardianship of our natural resources. Our Fishhook Summit continues to be a key event on our annual calendar for kaitiakitanga of our Taiao.
- Cultural Revitalisation: we continue to invest in the revitalisation of te reo Māori and cultural practices. We continue to support important kaupapa such as Toitū Te Reo, and events such as Waitangi Day, Matariki, Kahungunu Kapa Haka Festival, increasing numbers of participants engaged in their Kahungunutanga, reflecting a community proud of its identity and future. Our Communications team continue to keep our people informed and up to date in all matters relating to our iwi.

The financial performance of the iwi has remained robust despite volatile market conditions. Our investments have been carefully managed to mitigate risk while seeking sustainable growth. This prudent approach has ensured that we are able to continue supporting our social, cultural, and economic programmes.

A summary of our financial position and detailed accounts are provided in the Finance section of this report.

The coming year presents both opportunities and challenges. Major projects are planned in housing, education, and environmental restoration. We will continue to invest in our people, prioritise whānau wellbeing, and advocate for the rights of Ngāti Kahungunu. You would have seen the recent announcement to establish Te Toka Tū Moana o Ngāti Kahungunu (Kahungunu Health Authority) as a waka to drive health and well-being for our people. Kua takoto te mānuka, ā, mā mātou anō te mānuka e hiki! I encourage all whānau to remain engaged, to contribute ideas, and to hold us to account. Our progress depends on the collective energy and wisdom of our people.

Ngāti Kahungunu is defined by resilience, unity, and the unbreakable bonds of whakapapa. Our journey continues, guided by the wisdom of our ancestors and the aspirations of our mokopuna. As Chair, I am humbled to lead and proud of all we have achieved together. Let us move forward, united in purpose and heart, for the benefit of all Ngāti Kahungunu, today and for generations to come.

Chief Executive's Statement

As we reflect on the past year, we do so with pride, resilience, and a deep sense of responsibility. The shifting political landscape has tested our resolve, but it has also reaffirmed the strength of our whakapapa and the unwavering commitment we hold to our whānau, hapū, marae, and lwi.

This report and those from the Directorates capture the mahi of our Tari and partners - work that has been shaped over five years of strategic planning, collaboration, and advocacy. From housing developments to education initiatives, environmental protection to social wellbeing, every kaupapa is rooted in our collective vision: Kahungunu 2026.

We've faced challenges, including financial constraints and policy changes, but we've responded with innovation, unity, and aroha. Our Housing team continues to deliver homes and hope. Our Mātauranga team uplifts our tamariki and rangatahi. Our Taiao champions protect our whenua and wai. Our social wellbeing programmes, despite setbacks, remain a beacon of transformation and we continue to return benefits to our members through events, scholarships and sponsorships.

This year also marks a significant step in governance, as we prepare to align our constitutions with new legislative requirements i.e. Māori Fisheries Amendment Bill, Charitable Trust and Incorporated Societies Act - ensuring our structures reflect both tikanga and compliance.

The 2024/25 year was marked by significant progress across strategic priorities, despite external pressures from political and financial shifts. Ngāti Kahungunu lwi Inc continued to advance its Kahungunu 2026 vision through targeted mahi in housing, education, environmental advocacy, social wellbeing, and governance.

Key Highlights

- Political Advocacy: Ongoing monitoring of government movements and legislation impacting Māori priorities.
- Strategic Implementation: Continued rollout of initiatives developed over the past five years, aligned with Directorate goals.
- Financial Position: Reduced dividends prompted a shift in funding strategy. Surplus reflects capitalisation of housing assets, not available cash.

Housing:

- 20 of 34 papakāinga homes completed; remaining due by September.
- First affordable rental development (Ōtāne) near completion.
- Temporary accommodation and critical repairs delivered across Hastings and CHB.

· Education & Scholarships:

- 101 scholarships approved, totalling \$64,000.
- · Over \$200,000 invested in community projects.
- 40+ Ki te Ao Mārama podcasts now available.

Chief Executive's Statement

· Taiao Advocacy:

Focus on water access, whenua Māori, and flood protection research.

Social Wellbeing:

- Paiheretia programme discontinued due to government reprioritisation.
- Te Ara Matua progressing with support from Oranga Tamariki.
- Data systems in development to track impact and inform future investment.

Governance:

 Constitutional amendments underway to comply with Māori Fisheries Amendment Bill and other legislative changes.

Looking ahead Ngāti Kahungunu lwi Inc remains committed to upholding its obligations to whānau. The coming year will focus on strengthening partnerships, enhancing capability, and continuing to deliver kaupapa that uplift our people and protect our taonga.

To our whānau: thank you for your trust, your voice, and your unwavering support. We move into 2025/26 with clarity, purpose, and a deep commitment to serve.



Ngāti Kahungunu Iwi Incorporated Organisation Structure

Ngāti Kahungunu lwi Incorporated is governed by ngā uri o Kahungunu through its constitutional organisational structure. This diagram depicts the structure of the iwi from marae/hapū to governance and through to management and workstream level.



Te Reo, Tikanga & Matauranga

Te Reo, Tikanga & Mātauranga

Ngāti Kahungunu lwi Inc. continues to champion the revitalisation of Te Reo Māori and the advancement of Mātauranga Māori through strategic initiatives that empower whānau, uphold cultural identity, and strengthen iwi leadership. Despite political and financial challenges, the iwi remains committed to fostering language, education, and rangatiratanga across its rohe.

Te Reo Māori is a cornerstone of identity and wellbeing for Ngāti Kahungunu whānau. It enables the recognition of whakapapa, cultural values, and practices, and enhances self-worth and community participation. Internationally, Te Reo is a symbol of Indigenous strength and values-driven leadership.

Ngāti Kahungunu lwi Inc. advocates for the use of Te Reo in homes and businesses, promoting the preservation of Ngāti Kahungunu customs and language. Following the departure of the Director of Te Reo, Tikanga and Mātauranga, Dr Jeremy Tātere MacLeod, a review of the Kahungunu Kia Eke strategy was commissioned to assess progress and plan next steps. However, reduced KAHC dividends and political shift such as the removal of Te Reo and Te Tiriti o Waitangi principles from government policy constrained funding. Dr Tātere MacLeod continued the revitalisation of te reo Māori through Kauwaka which was established in 2020 as a vehicle to contribute to the language and cultural revitalisation efforts within Ngāti Kahungunu.

Key Activities (2024–2025)

- Toitū Te Reo Festival (August 2024):
 Over 5,000 attendees participated in workshops and seminars catering
 to all proficiency levels. The event aligned with Kahungunu Kia Eke
 outcomes and celebrated reo revitalisation.
- Kura Reo Events:
 Crown funding limitations impacted the delivery; this priority will be reviewed during the strategy refresh.

Quality education is essential for whānau to enhance earning potential, skills, health, and mana motuhake. The refreshed Mātauranga Strategy set a clear action plan to address inequities and promote lifelong learning. The strategy is embedded across all Tari functions including: Events, Te Ara Toiora, Te Reo, and Taiao, creating opportunities to engage whānau of all ages. Building Tiriti-based relationships with the Ministry of Education and other Crown agencies remains a priority.

Key Activities (2024–2025)

- Te Ao Mārama Podcast Series:
 - Now featuring 43 episodes, the podcast explores iwi knowledge and priorities, bridging cultural gaps and promoting Mātauranga Māori.
- Tiro Maroro Pilot Project:
 - A co-designed evaluation framework with Heretaunga schools and kindergarten, focused on restoring rangatiratanga in education. The draft report is nearing completion.
- Mātauranga Symposium (January 2025):
 - A well-attended event that brought together educators, whānau, and officials to reflect on Māori learner engagement across all education levels.
- · Discontinuation of STEM Forum:
 - Legislative changes led to the forum's closure, redirecting efforts to a shared data project aimed at identifying intervention points for Māori student achievement.

The Ngāti Kahungunu Mātauranga Strategy, remains the guiding pou for our iwi education aspirations. This year we celebrated its activation through flagship initiatives that reconnected whānau to mātauranga and built new pathways for learning, collaboration, and success.

Te Reo, Tikanga & Matauranga

The Te Ao Mārama Podcast initiative will continue as we provide ongoing support to showcase leadership and inspire emerging rangatira. The organisation is committed to providing Internship & Mentoring Programmes to help nurture future iwi leaders.

Ngāti Kahungunu advocates for the protection and restoration of our environment, and empowers whānau and hapū to exercise their taiao rangatiratanga and to live as 'tangata whenua'. We acknowledge the intrinsic link between identity, well-being, our values and te ao turoa – expressed through our taonga, mahinga kai and associated practices.

Over the last 12 months, the Kahungunu Taiao team has been actively engaged in environmental monitoring, research, and advocacy on critical issues, including:

- Rivers and flood control research Mana Awa, Mana Whenua, Mana Tangata, restoring space for our waterways, Ngaruroro and Tukituki.
- Groundwater and hydrological processes research to future-proof groundwater management.
- Waterway monitoring, cultural assessments, audits, hapū and whānau support and capability building - Makaroro, Blackbridge Landfill, Tutaekuri, Awatere, Paritua, Karewarewa, Ngaruroro, and Wairoa
- Marine research: Work on the Marine Cultural Health Index, marine carbon dioxide removal, mussel spat collection, seafloor springs, pāua research, and ocean acidification.
- We emphasise the reciprocal relationship between research, monitoring, and policy development. The evidence we gather both strengthens environmental management and informs policy, creating a cycle of continuous improvement and adaptation.

Ngāti Kahungunu Freshwater Objectives

- · Revitalise the Mauri of waterways.
- · Restore and repatriate Mahinga Kai.
- · Protect, restore, maintain safe and reliable waimāori sources.
- Ensure rangatiratanga and kaitiakitanga is recognised and provided for.
- Safeguard pepeha o ngā wai (traditional waters) are safe for swimming, immersion, cleansing and rituals (Uu).

Te Taiao Me Ōna Rawa



- · Protect waahi taonga, waahi tapū.
- Protect whakapapa of waterways and natural systems.
 Our commitment has been to advance taiao aspirations through collaboration and transparent advocacy. This year, alongside hapū and Taiwhenua, we have:
- Advocated for Heretaunga and Ahuriri Freshwater (TANK) Catchment Plan, focusing on restoration, protection, and water quality/quantity targets (awaiting Environment Court evidence exchange).
- Opposed Ruataniwha groundwater takes to protect diminishing groundwater, streams, springs, mauri, and mahinga kai (awaiting Environment Court ruling).
- Secured recognition of outstanding waterbodies in Hawke's Bay (successful Environment Court ruling).
- Supported opposition to the Maraekakaho Quarry in a floodplain (successful High Court ruling).
- Continued involvement in consent condition implementation for gravel extraction (Tukituki, Tūtaekurī, Ngaruroro), Wairoa Wastewater, and Ravensdown stormwater and air discharge.
- Submitted on legislative reforms, including the fast-track process, Local Water Done Well (Three Waters), RMA reforms, and Fisheries Act amendments.

This year we hosted the 14th Annual Kahungunu Fish Hook Summit – Measure, Monitor, Manage and Restore – which showcased work from across our rohe. We have also been invited by Te Wai Māori Trust to help host the National Māori Freshwater Fisheries conference in late 2026 or early 2027 (TBC).

The focus remains on asserting our rangatiratanga and protecting the environment for the well-being of current and future generations.

Te Ara Toiora - Pathway to Wellbeing

At Ngāti Kahungunu lwi Incorporated we remain committed to working with whānau and key partners to tackle entrenched social inequities that disproportionately impact our whānau and hapū. These persistent challenges including financial hardship through the cost of living crisis, high unemployment and lower household income contribute to; family harm that erodes whānau stability and safety; the lack of economic equality and purpose; disproportionate representation in the justice system, perpetuating cycles of disadvantage; limited access to affordable housing, creating insecurity and unhealthy living conditions; and systemic and institutional barriers to equal opportunities all continue to undermine whanau wellbeing the vitality and prosperity of our, hapū and iwi.

Our strategic objective of 'Strong, Vibrant, and Healthy Whānau and Hapū' guides our efforts to address these inequities. We are dedicated to supporting our whānau to achieve economic self-sufficiency and stability, live free from violence and harm, access quality education, training, and employment opportunities, enjoy good health and wellbeing, and to strengthen whakapapa connections.

We listen to and amplify the unfiltered voices of our whānau, to shape our approach and inform partnerships with Crown agencies and Kaupapa Māori service delivery providers. Our commitment to whānau-centricity ensures that our efforts remain focused on the needs, aspirations, and priorities of our people as determined by them. By amplifying whānau voice and partnering with like-minded organisations, we co-create transformative change that honours the mana of our whānau. Programmes like Te Ao Marama, Paiheretia te Muka Tāngata, Te Kura and Te Ara Mātua prioritise whānau needs, promoting improvements in wellbeing, economic stability, capability and whānau resilience.

We have moved from design to implementation in major pieces of work. This is only possible through the continued trust and confidence of our funding and design/delivery partners with Ngāti Kahungunu lwi Inc.

These partnerships delivering co-creations, co-implementation enable the lwi to provide insights to an alternative way of responding and supporting whānau to become "wāhine purotu, tāne purotu".

By working together, we're championing a more just and equitable system, addressing systemic barriers and amplifying whānau voices. These collaborative initiatives, brings together whānau, Te Tumu Whakahaere of Te Wero (Te Wero), Oranga Tamariki, Te Puna Aonui, Ministry of Social Development, New Zealand Police, the Ministry of Justice and the Judiciary to achieve significant milestones.

Te Kura - Whānau Safety First

Te Kura represents a Ngāti Kahungunu-led approach to Whāngaia Ngā Pā Harakeke, a New Zealand Police initiative designed to foster collaboration between iwi, government agencies, and community organisations to reduce family violence and harm within the community.

Throughout the year, Te Kura has embraced a series of transformative changes, significantly strengthening its partnerships with Police, government departments, and community organisations across Hawke's Bay. Guided by a vision of collective empowerment, our focus has been on cultivating genuine, enduring relationships with the wider community to support whānau to live free from violence and harm.

A key development this year was the addition of two new kaimahi to our team, a dedicated Coordinator and an Administrator, whose contributions have enhanced our operational capacity and supported the delivery of more responsive, whānau-centered services.

Our strategic goals and objectives for the year have included:

- Strengthening governance and leadership
- Promoting flexible, targeted, and integrated investment

Te Ara Toiora - Pathway to Wellbeing

- Encouraging collaborative and culturally responsive ways of working
- · Delivering safe and effective responses to risk and need
- Fostering innovation and continuous improvement
- Ensuring child and victim centered approaches remain at the heart of our mahi

To support these goals, we hosted a series of wānanga and actively engaged with The Centre (Formerly the Joint Venture and Te Puna Aonui) alongside local community organisations, whose insights and lived experiences have helped shape our direction for the coming year.

Te Ara Mātua - Mokopuna-Centered Care

Te Ara Mātua is designed with whānau, for whānau. It's a partnership with Oranga Tamariki and Te Wero that aims to transform how Mokopuna and their whānau experience care and support. The programme focuses on whakapapa, connection, and healing, making sure our Mokopuna are surrounded by aroha, not bureaucracy. It's about restoring mana and creating pathways for whānau to thrive together.

This year Te Ara Mātua hubs were opened in both Napier and Hastings to act as a safe place for whānau to meet and access support from Te Wero service providers including care, home and youth support services, training, development and wānanga. By uniting community experts and stakeholders, the hub ensures early and effective responses to tamariki and whānau needs.

Paiheretia Te Muka Tāngata - Justice with Whānau at the Centre

Although this programme has been discontinued due to government changes, Paiheretia made a real difference for whānau navigating the justice system. It offered early support in courts and connected whānau to services that understood their needs. The kaupapa showed that when whānau are supported with dignity and care, outcomes improve. Its legacy continues to shape how we advocate for justice reform.

Te Ao Mārama - Amplifying Whānau Voices in Justice

Iwi aspiration is for whānau to live free of the justice system, however if connecting with the system we want to ensure it is supportive of whānau aspirations to become strong, vibrant, healthy hapū and whānau.

Te Ao Mārama is about changing the justice system by listening to the real stories of our whānau. Over 1,000 whānau shared their experiences, helping to shape insights and solutions for change. This kaupapa brings together lwi, Te Wero, the Ministry of Justice, and the judiciary to cocreate a system that works for Māori. It's about making sure our voices lead the way in building a fairer future.

E Tū Whānau - Standing Strong Together

E Tū Whānau is a movement that celebrates the strength, resilience, and mana of whānau. It supports community-led solutions to reduce harm and build safe, loving environments. Whether it's through wānanga, storytelling, or local initiatives, E Tū Whānau reminds us that change starts at home, with aroha, respect, and unity.

Bail Support - Aroha in Action

Bail Support helps whānau who are going through the justice system by offering tailored support while they're on bail. It's about keeping people connected to their whānau, their culture, and their community. The kaupapa reduces remand rates and gives whānau a better chance to rebuild their lives with dignity and support.

Te Ara Toiora-Whai Kainga, Whai Oranga

The Ngāti Kahungunu Kāinga team is extremely proud of our accomplishments made for the 2024-2025 year. We have completed multiple papakāinga developments, including 20 whare with another 14 to complete in the coming months. Our affordable rental programme has several projects in the pipeline for the year ahead, with work already beginning in Woodville, Waipawa & Flaxmere. Our most recent project was providing 20 homes in Otane. Finally, NKII were contracted to provide critical repairs to whānau directly affected by the cyclone. This program is still ongoing with 39 assessments approved and 37 sites completed, 2 more sites to be scoped out.

These milestones reflect the dedication and commitment of our team and all those who have supported and contributed to this important kaupapa for our iwi. This year alone, over 50 whānau have benefited from our housing initiatives, a testament to the reach and impact of our mahi.

We also warmly welcome a new member to the team, Tori Paewai, whose primary focus is managing our cabin consent plan with Hastings District Council (HDC). Her contribution strengthens our capacity to meet housing timelines and our overall goals for the year ahead.

Throughout the year, we've continued to work closely with local and central government, community partners, and whānau to ensure our housing solutions reflect the values, needs, and aspirations of Ngāti Kahungunu.

Looking ahead, our mission remains the same: to continue implementing pathways to support financial empowerment, security, and affordable housing solutions. We will continue exploring innovative housing models and sustainable building practices that align with both tikanga, environmental stewardship and enabling the long-term well-being of whānau.

COMMUNICATION

This reporting year brought its share of challenges, as we responded to the many changes unfolding across our communities. Despite this, we've remained steadfast in our commitment to sharing uplifting stories, celebrating those making a positive impact in our communities, and keeping our whānau informed. Our website www.kahungunu.iwi.nz and Facebook page continue to be regularly updated to ensure we reach as many people as possible. A special highlight this year was celebrating the 10th anniversary of Tihei Kahungunu, our 8-12 page tabloid featured in Hawke's Bay Today, which continues to amplify iwi voices and achievements.

REGISTRATION

As of 30 June 2025, the Ngāti Kahungunu lwi Inc Registration Database increased by 1207 members, taking our overall total of registered members to 41305.

- 68% of these new registrations came from Heretaunga and Wairoa Taiwhenua.
- 17% or 7421 registered members have an incorrect address whānau frequently move without updating their information.
- This year, we have set an ambitious goal to reduce the number of incorrect addresses to 15%
- 4% or 1707 registered members do not have a date of birth & were unable to participate in iwi elections.
- 27% or 11325 registered members have requested and received iwi membership Cards

NKII BOARD ELECTION REPORT

The Ngāti Kahungunu lwi Incorporated Board Elections take place every three years. Nine (9) elections take place simultaneously for ten (10) positions on the Board as follows; The election of six (6) Taiwhenua/Rohe representatives, two (2) Taurahere representatives (from the Northern and Southern Districts), one (1) Kaumatua representative and (1) Chairman position. The 2025 triennial election took place on 24 April 2025. Of the 23,489 voting papers issued, 4,789 were completed and returned, this is a 20.39% return. These statistics are very low. Ngāti Kahungunu lwi Incorporated is always looking for ways to encourage whānau to update information on the registration database so we can communicate more effectively. Pathways forward include communicating with whānau earlier and empowering whānau to be involved as soon as they turn 18yrs.

EVENTS - WHAT DID WE DO? WHY DID WE DO IT?

Ngāti Kahungunu lwi Incorporated delivered a robust calendar of free or low-cost community events to uplift the mana, wellbeing, and connectedness of our iwi members and wider communities. E ngā mana, e ngā reo, e ngā iwi o Ngāti Kahungunu, tēnā koutou katoa It is our privilege as Co-Chairs' of Kahungunu Asset Holding Company Limited (KAHC Ltd) to present to you the report of KAHC Ltd for the 2025.

This year we continue to shift from non-productive investments toward a more proactive, disciplined investment pipeline consistent with the Statement of Corporate Intent (SOCI). The Board continues emphasis on balancing yield and growth to deliver sustainable dividends to the shareholder while protecting long-term asset value.

Despite ongoing volatility in fisheries and property markets, KAHC delivered a stable operational financial performance, with disciplined cost management and steady asset growth. As a result KAHC has maintained capacity to declare a dividend to NKII demonstrating strong alignment between commercial performance and iwi distributions.

KAHC delivered a strong operational profit of \$2.22 million in FY2025, reflecting steady performance across the portfolio. After property and asset revaluations are taken into account, the Company reports a comprehensive income of \$213,032.

A reduction in the value of Aotearoa Fisheries Limited shares and a decrease in the value of the Pandora properties were partially offset by a \$2.4 million uplift in the valuation of Tautane Station - underpinned by renewed confidence in the sheep and beef sector.

In April 2025, we acknowledged the resignation of Bayden Barber as the NKII representative on the Board, and thank him for his service and contribution to KAHC during his tenure. We are also pleased to confirm that Hayden Hape joined the Board in September 2025, bringing additional expertise and perspective to our governance table.

The year ahead sees us exploring potential partnerships in fisheries, property development and aquaculture, with a continued commitment to delivering enduring value for shareholders and iwi through growth and diversification.

Nature and Scope

KAHC Ltd holds charitable tax status as it is entirely owned by its shareholder, Ngāti Kahungunu lwi Incorporated. KAHC Ltd received settlement assets on behalf of Ngāti Kahungunu lwi Incorporated and these assets are subject to trading restrictions.


The settlement assets are managed in accordance with the Company constitution and the Māori Fisheries Act 2004. The Company also holds non-settlement assets that are not subject to any trading restrictions.

Financial Performance FY2025

The KAHC Group has recorded:

- an operating profit of \$2,217,774
- · total comprehensive income of \$213,032
- retained earnings of \$22,566,772
- equity of \$75,363,323





Annual Catch Entitlement (ACE)

KAHC Ltd is one of 42 iwi groups who lease their deepwater ACE to Sealord under Ngā Tapuwae o Māui. Ngā Tapuwae o Māui is a strategic partnership between Sealord and iwi that secures long-term access to iwi-owned quota while returning the majority of profits to iwi shareholders, strengthening iwi participation across the fisheries value chain.

KAHC leases its inshore ACE to Moana New Zealand, ensuring stable returns from New Zealand's largest Māori-owned fisheries company. While the value of ACE can fluctuate with sustainability settings and market demand, this partnership provides long-term security and alignment with iwi interests.

KAHC has leased its koura ACE to Fiordland Lobster Company under a long-standing arrangement in place since 2016, providing consistent returns from New Zealand's leading lobster exporter. The lobster market (and the subsequent impact on quota prices) has taken a hit with the Australian lobster entering back into the Chinese market.

The balance of ACE is leased on a competitive tender basis to a range of fishing companies, including Sea Eagle Scampi, Sea Urchins New Zealand, Maruha Limited and Pelco NZ Limited.

For the last five years, KAHC has leased ACE from Ngāti Ranginui, which has been parcelled up with KAHC ACE and leased to fishers mentioned above. This lease agreement has now come to an end, and KAHC has decided to focus on maximising returns from its own ACE.

Overall, the returns on the fisheries quota for the FY2025 year was \$3.22m. Shares

KAHC Ltd currently hold 31,496 shares in Aotearoa Fisheries Limited (AFL, trading as Moana NZ) which equates to a 6.3% holding. Last year, Te Ohu Kaimoana undertook a valuation exercise on behalf of the AFL iwi shareholders. As such KAHC updated the AFL shares valuation from \$14.17m to \$9.98m. The decrease reflects a non-cash accounting adjustment, which aligns with new reporting standards. This adjustment does not affect our proportional shareholding or dividends received.

The Gross Dividend received from the AFL shares for FY2025 was \$502,478 compared to the previous year of \$107,672. Moana New Zealand delivered operating earnings of \$12.4 million, 13% ahead of the prior year and 6% above plan, driven by strong cost savings despite lower harvest volumes and delayed vessel access.

As at 30 June 2025, KAHC owned 89,670 shares in Fiordland Lobster Company (FLC). In October 2025, these shares paid a \$3.35 dividend per share (a total of \$300,395).

Napier Mussels Limited

KAHC Limited holds a 91% interest in Napier Mussels Limited, which owns a mussel farming consent off the coast of Waipatiki. While there was no operational activity during FY2025, KAHC has engaged with MPI and Whakatōhea Mussels on the potential for a spat-catching trial. Subject to feasibility, this initiative is expected to commence in FY2026, creating a pathway to explore future aquaculture opportunities.

PROPERTY

Pandora Road

The former Takitimu Seafoods site at 52 Pandora Road is a leasehold property with Napier City Council and is currently partially tenanted. Its valuation decreased from \$2.0m to \$0.9m over the past year, reflecting limited tenancy at the time of assessment (a second tenant has since been secured), increased council rates, and the pending ground rental review. Ultimately, the existing buildings do not maximise the potential of this prime waterfront location, which underpins KAHC's medium-term objective to freehold the site and unlock its long-term value.

At 43 Pandora Road, the property is mostly fully leased to a mix of tenants and provides steady rental income. The valuation remained stable at \$4.56m over the past 12 months, with a modest uplift also recorded for the nearby Humber Street carparks. Development of 43 Pandora remains a long-term vision for KAHC, with current leasing arrangements ensuring ongoing income while strategic options are considered.

These Pandora Road properties represent important long-term opportunities within KAHC's commercial property portfolio.

Tautane Station

KAHC Ltd owns Tautane Station, a 3,500 ha sheep and feed breeding/semi-finishing station situated at Herbertville, 66 kms southeast of Dannevirke.

Tautane's valuation increased from \$30.5m to \$32.9m, reflecting renewed strength in the sheep and beef sector, with higher commodity prices across lamb, beef, and wool. Reduced forestry demand and strong sales activity have lifted confidence, while Tautane's scale and farm improvements continue to support favourable returns.

Kahutia

Kahutia is a forestry production and carbon trading company established in 2019. The partnership with Tangoio South Trustees (5%) and Hineuru Holdings Limited (47.5%) and KAHC Ltd owns a 47.5% share.

Equity-accounted investment value at year end shows \$1,073,758 profit for KAHC Ltd. Largely reflecting a valuation of the trees and carbon crop.

COMPANIES THAT HAVE CEASED TRADING

K3

K3 Development Limited Partnership (and its GP company) was formally resolved to be wound up (17 June 2024). It is now reported as a discontinued operation in KAHC's consolidated accounts. At 30 June 2025, K3 showed a small loss before tax of \$9,961.

Takitimu Seafoods

Takitimu Seafoods Limited Partnership was resolved for termination in April 2023. Following the completion of the Cyclone Gabrielle insurance claim in June 2025, the Board is working though the wind-up processes. While cashflow was positive for the year, reflecting the final insurance payouts, a loss of \$350,840 reflects the write-off of fixed assets.

Māori Fisheries Amendment Act

The Māori Fisheries Amendment Act 2024 introduced new requirements to improve governance and reporting across iwi fisheries. For KAHC, this means stronger obligations around transparency and quota management to ensure our fisheries assets continue to deliver long-term benefits for Ngāti Kahungunu.

FOR THE YEAR ENDED 30TH JUNE 2025

Ngāti Kahungunu lwi Incorporated (the controlling entity) is an Incorporated Society registered under the Incorporated Societies Act 1908 and a charity registered under the Charities Act 2005.

The financial statements comprising the controlling entity and its controlled entities, Kahungunu Kāinga Limited, Kahungunu Asset Holding Company Limited, Takitimu Seafoods Limited Partnership, Takitimu Transport Limited, K3 Development Limited Partnership and Napier Mussels Limited, together the "Group", are presented for the year ended 30 June 2025. The Group is a reporting entity for the purposes of the Financial Reporting Act 2013.

The summary figures provided are taken from the full financial statements which have been subject to an audit.

Ngāti Kahungunu lwi Incorporated is deemed to be a Public Benefit Entity as its primary objective is to provide goods and services for community or social benefit.

The Group financial statements have been prepared in accordance with Generally Accepted Accounting Practice in New Zealand (NZ GAAP). As it was eligible to, Ngāti Kahungunu lwi Incorporated has elected to move back to Tier 2 PBE standards (PBE Standards RDR) this year.

The significant accounting policies used in the preparation of the financial statements are set out in the full version of the financial statements.

The Group has changed its accounting policy for non-settlement fishing quota shares from the cost model to the revaluation model. There was no effect on these financial statements as disclosed in the full version of the financial statements.

The Group has also changed its accounting policy for shares in Aotearoa Fisheries Limited received under the Fisheries Asset Settlement process. These shares were previously included at cost on transfer because fair value could not be reliably measured in previous periods and have been adjusted to fair value as at 30 June 2025. This resulted in a fair value loss as disclosed in the full version of the financial statements.
